1. All bowlers must show USBC card, will be **verified at check in.**
- 2) Two divisions one women's: A-151 & above; B-150 & below and Men's A-161 & above; B-160 & below
- 3) Handicap = 90% of 220. We will bowl three games of 9 PIN NO-TAP. **CHECK IN AT 12:00 PM.**
- 4) ENTERING AVERAGE: Composite average 2023/2024 will be used found on Bowl.com. If no book average, use your highest 2024 summer average of 21 games or more with **verification**. If no average, bowler will bowl scratch. Failure to use correct average will disqualify score. Winnings will be based on average and handicap.
- 5) A bowler arriving late must start in frame being bowled and shall receive 0 for frames missed. **NO REFUNDS.** Substitutes will be permitted if all qualifications, including average are verified prior to squad time.
- 6) Prize Fund will be returned 100% at a ratio of 1 out of 5 entries. In case of ties, that place will be combined with the next place and divided equally. Awards will be mailed within thirty (30) days of tournament.
- 7) Lanes will be assigned as entries come in, Entries must be received by midnight of closing date. **IF YOU WISH TO BOWL WITH SOMEONE, PLEASE MAIL ENTRIES ALL TOGETHER.**
