## **TOURNAMENT STANDING RULES:**

1. All current USBC members are eligible to participate. One member of each team MUST be a member in good standing in their local 500 club.
2. The tournament shall be bowled in one (1) division. In the case of ties, prize money is combined and then equally divided, unless the tie is for last place, in which case duplicate awards will be made. If the tie is for first place, duplicate awards will be given out and a co-champion will be declared.
3. USBC Rule #319d and 319e will not apply, but 319 a3 will apply.
4. Entering average will be the 2023-2024 USBC book average. If no book average, use highest current average of 21 games or more as of the tournament closing date. Bowlers with none of these averages will bowl scratch. Current averages must be verified by the League Secretary.
5. The tournament will be a 3-game 9-pin no-tap doubles event on one pair of lanes.
6. A bowler arriving late must start his or her game in the frame which is then being bowled and shall receive "0" score for frames missed. He/She will not be permitted to make up frames.
7. Any bowler who does not finish scheduled game or games will be given credit only for scores bowled.
8. A dispute of any nature, except scoring, shall be immediately referred to the Tournament Officials, Local Association or to the USBC before prize payments are made. The grounds of appeal or protests shall be clearly and briefly stated. A dispute in scoring shall be made to the Tournament Officials within 24 hours.
9. If equipment failure on the assigned lanes should delay the normal progress of the series, the Tournament Officials may authorize the completion of a game or series on another pair of lanes. Interrupted games and series must be resumed from the point of interruption.
10. Entry fees must accompany all entry forms. Cash, check or money orders are accepted. Bowlers wishing to bowl together should send entries in together. Walk-ins cannot be accommodated for this event. Entry fees will not be refunded after the closing date.
11. Bowlers participating in the tournament may not practice on lanes scheduled for play within one hour before squad time.
