**RULES:**

1. Entrant **MUST** be a FEMALE. Must be a member of USBC and CA Women’s 500 Club member in good standing. Duplicate CA Women’s 500 Club cards are available for purchase (\$5.00) by mail. Membership will be verified before issuing card.
2. Handicap 90% of 220.
3. ENTERING AVERAGES:
  - A) Highest 2023-2024 USBC certified book average (min. of 21 games). If none,
  - B) Highest 2024-2025 USBC certified book average (min. 21 games) as of tournament date (sheet required if not posted on BOWL.com). If none,
  - C) Highest 2023-2024 USBC certified Composite book average (min. of 21 games).
  - D) If none, scratch 220

Bowlers are responsible for verifying their own average. If a “sport/challenge” average is the bowler’s only verifiable average, it must be marked with “SP/CH” and will be adjusted per the USBC sport chart.
3. Rules 319a2 and 319d will be waived. Rule 319c will be applied for current averages that are 10 pins higher than last year’s book. If the assigned average is not accepted by the bowler, the entry fee shall be refunded. Bowlers on the USBC re-rate list must report the re-adjusted average or be subject to disqualification without refund.
4. All USBC rules prevail, and anything not covered above will be decided by the CA Women’s State 500 Club Tournament Committee.
5. Prize fund 100%, one cash award for every four (4) entries
6. Bowl CA Women’s 500 Club Annual Tournament by using your team handicap scores bowled in Women’s or Open Championships tournament in CALUSBC TEAM Event. Entrant will use her team event score as her 500 singles score plus handicap. ENTRY FEE must be paid prior to bowling your CAUSBC team event. We will have three divisions (A, B, C) in the CA Women’s 500 Club Annual tournament.

7. A bowler can cash only once in Women's State Division and only once in Open Championships, must pay two Annual Tournament entry fees if entering in both.
8. Dead line for receiving scores must be post marked by June 14, 2025 no later than 11:59 PM or you shall receive a score of zero (0).
9. A copy of your recap sheet is required to show proof of scores. Send recap by mail, e-mail, or text. Be sure it is clear to read. Deadline for scores is June 14, 2025.
10. If bowling in the Women's and the Open Championships you will need to send in your scores for both on separate score verification forms.
11. A reminder to send in your scores can be sent out to you if indicated on entry form in either email or text or both. Entry must reach me before you are bowling in order to receive a reminder.
