1. Entrant must be female in good standing with USBC and State 500 Club. Each entrant is required to show her current USBC and State 500 Club cards at check in. Duplicate 500 cards will be available for purchase (\$5.00) at the tournament site.
2. Open to UNLIMITED 500 Club bowlers selected by your club and any female whom has bowled a 500-scratch series providing proof, has a current USBC membership and a CA Women's 500 Club membership.
3. If local club has a uniform, it may be worn.
4. Handicap will be 100 percent of 210.
5. Entering Average:
 - a. 2023-2024 USBC Highest Standard Composite Average
 - b. Highest 2023-2024 or 2022-2023 average of all USBC leagues (minimum of 21 games).
 - c. If none, then use a current single USBC league average (minimum of 21 games) Winter and Summer as of tournament date. League sheets for all leagues or bowl.com printout must be provided). The bowler is responsible to verify the accuracy of her averages.
 - d. Bowlers with neither of the above averages must bowl scratch (210).
 - e. If current season average for at least 21 games at the time of bowling exceeds last season's average by 10 or more pins, current season average must be used **(Rule 319a-2)**.
 - f. Reporting of previous tournament winnings will apply **(Rule 319d)**.
 - g. The average adjustment rule will apply **(Rule 319e)**.
 - h. It is each bowler's responsibility to verify the accuracy of their own average in handicap or classified tournaments, whether originally submitted by the bowler, the team captain or others. Failure to use the correct average may disqualify the score if submitted average is lower than correct average, thereby resulting in a lower classification or more handicap. Prize winnings will be based on the submitted average, if it is higher than the correct average **(Rule 319a-3)**.

6. BOWL.COM AVERAGE PROFILES MUST BE PROVIDED AT CHECK-IN. If profiles are NOT provided at check-in bowler will enter at 210 for brackets/side pots and tournament. Verification can be in the form of printed sheets from bowl.com or shown on an electronic device.
7. AVERAGES ARE VERIFIED BY TOURNAMENT MANAGER. All averages must be certified by your local Secretary or President by initialing the average on the application.
8. Protests - **Rule 329** - Protests involving eligibility or playing rules must be made to tournament management in writing within the time limits in **Rule 329**. The decision of tournament management will be final unless a written appeal is filed with USBC Headquarters within the time limits in **Rule 329**.
9. **Two** winners from each division will be determined by highest three game series with handicap. In the event of a tie, for 1st both bowlers will advance. In the event of a tie for 2nd place a one frame roll-off will be used to determine who will advance.
10. The division winners will then immediately bowl a 1 game roll-off to determine the 2025 Princess. In the event of a tie, a two-frame roll-off will be bowled immediately.
11. **SQUAD TIME: 10:00 AM BOWLERS CHECK IN 9:00 AM – 9:45 AM PRIOR TO SQUAD.**
12. Prize Fund will be returned 100%. One cash award for every four entries. Checks will be issued within 30 days following the end of the tournament.
13. There will be side pots and handicap brackets available.
14. No Subs or Pacers Allowed.
15. USBC rules will prevail on any rule not covered. Any dispute will be left to the discretion of the tournament committee and tournament director.
16. Lanes will be assigned as entries are received.
17. A bowler arriving late must start in the frame being bowled and shall receive "0" for frames missed.
